Overview

The Register of Ultimate Beneficial Owners, Nominators and Appointors Regulations 2017 (“**RUBOR**”) establishes the legal framework for the collection and maintenance of information relating to the ultimate beneficial ownership of legal persons in Gibraltar.

RUBOR aims to enhance the transparency of ownership information and combat financial crime, such as money laundering and terrorist financing.

This guidance takes you from incorporating an entity in Gibraltar through to creating the accounts you need in order to file your Ultimate Beneficial Owner (UBO) submission online.

Who must complete a UBO submission

- Any corporate or legal entity incorporated in Gibraltar.
- Foundations and similar legal arrangements with tax consequences in Gibraltar.

Are you a trustee of an express trust with tax consequences?

As per the Trust (Information) Regulations 2025, trustees of express trusts with tax consequences in Gibraltar no longer need to file UBO information on the UBO Register. All trusts are required to submit necessary information to the Gibraltar Financial Services Commission. For any queries, please contact trustnotification@fsc.gi.

Key timelines

- New entities must register within 30 days of incorporation.
- Existing entities must file within 30 days of a change in UBO details.

Failure to comply with RUBOR

Please note that Failure to comply with RUBOR may result in legal and financial penalties, including fines and restrictions on the company’s ability to conduct business. It is essential for entities to understand their obligations and take proactive steps to ensure full compliance.

Before you start: incorporation and credentials

1. Incorporate the entity with Companies House Gibraltar
<https://www.companieshouse.gi/index.html>
2. Request E-Filing credentials from Companies House Gibraltar. You can request it by sending the [Application Form](#) by emailing to mail@companieshouse.gi.

Create your corporate access to the Government E-Gov portal

1. When you receive your E-Filing credentials, register for a corporate account via <https://login.egov.gi>.
2. Upon completion, the user will select their own login credentials when creating the E-Gov account.
3. Using these credentials, you will be able to access the UBO portal, found using the following link, <https://uboregister.egov.gi>.

Important

Historical submissions are linked to the specific eGov account used to access the portal. We recommend using a centralised corporate email account so that the full submission history for the Company is retained and accessible. If a new email address is used for submissions, the previous history will not be visible to that account.

At present there is no agent structure, so companies cannot be linked directly to a UBO account login. Each Company will require its own centralised corporate email account.

Information you will need for your first submission

Part A (entity details)

- Legal name of the entity and Companies House Registration Number (EICN). Please ensure that the legal name and EICN in Companies House matches exactly with the UBO Registration.
- Registered office address.
- Management service provider or TCSP details where applicable.

Part B (UBO details)

- Individual: Full name, date of birth and residential address exactly as in source documents.
- Listed Entity: Name, Markets listed, and registered address
- Other Registrable Person: Name, type and registered address
- Nature of ownership or control, including percentage of shares and voting rights.
- Registration date as an Ultimate Beneficial Owner.
- Cessation date (if applicable)

Part C (Senior Manager details)

- Full name and date of birth exactly as in source documents.
- Residential address.
- Role and basis for inclusion as a Senior Manager.
- Registration date as an Ultimate Beneficial Owner.
- Cessation date (if applicable)

Part E (Nominator Details)

- Name of UBO
- Individual Nominator: Full Name, nationality, previous names/alias, gender, place of birth, occupation, date of birth, usual residential address, service address if different, registration date as a Nominator, cessation date if applicable
- Company or Legal Entity Nominator: Name of company, registered office address, country of incorporation, incorporation number, registration date as a Nominator
- Legal Arrangement Nominator: Name of legal arrangement, full names of all trustees, principal office address, legal form, governing law, incorporation/registration number if applicable, registration date as a Nominator, cessation date if applicable
- Listed Entity Nominator: Name of listed entity, legal form, governing law, registered office address, name of market where shares are admitted to trading, country, registration number, registration date as a Nominator, cessation date if applicable
- Regulated Firm Nominator: Name of regulated firm, legal form, registered office address, country, permitted businesses under Part 7, permission number(s), registration date as a Nominator, cessation date if applicable

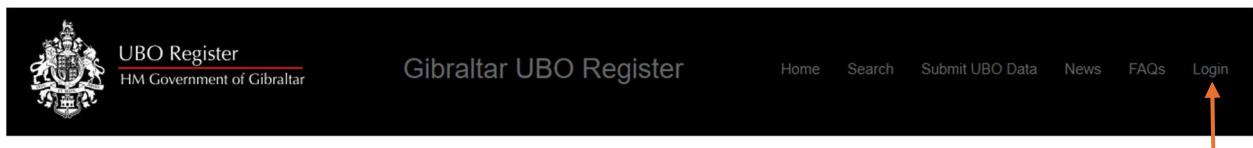
Part F (Director / Appointor details)

- Director: Full Name, date of appointment as director, date ceased as director if applicable
- Individual Appointor: Title, Full Name, nationality, previous names or alias, gender, place of birth, occupation, date of birth, usual residential address, service address if different, registration as an Appointor, cessation date if applicable
- Company or Legal Entity Appointor: Name of company or legal entity, principal office address, country of incorporation, incorporation number, registration as an Appointor, cessation date if applicable
- Legal Arrangement Appointor: Name of legal arrangement, principal office address, legal form, governing law, incorporation or registration number if applicable, registration as an Appointor, cessation date if applicable
- Listed Entity Appointor: Name of listed entity, legal form, registered office address, name of market where shares are admitted to trading, country, registration number, registration as an Appointor, cessation date if applicable
- Regulated Firm Appointor: Name of regulated firm, legal form, registered office address, permitted businesses under Part 7 of the Financial Services Act 2019, country, permission number or numbers, registration as an Appointor, cessation date if applicable

Note: Keep names and dates of birth exactly consistent across all submissions. This avoids duplicate entries and ensures changes are applied to the correct record.

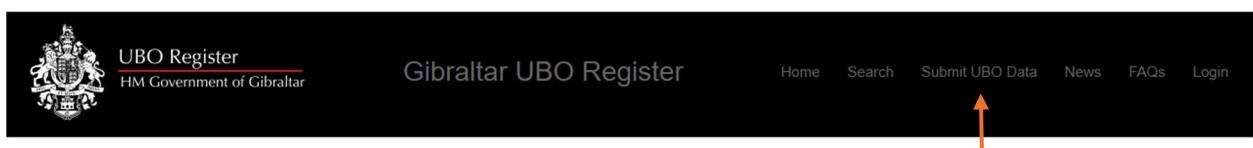

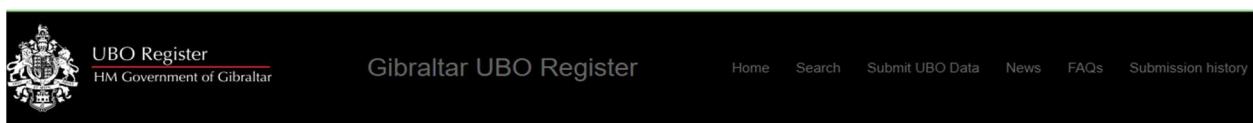
